

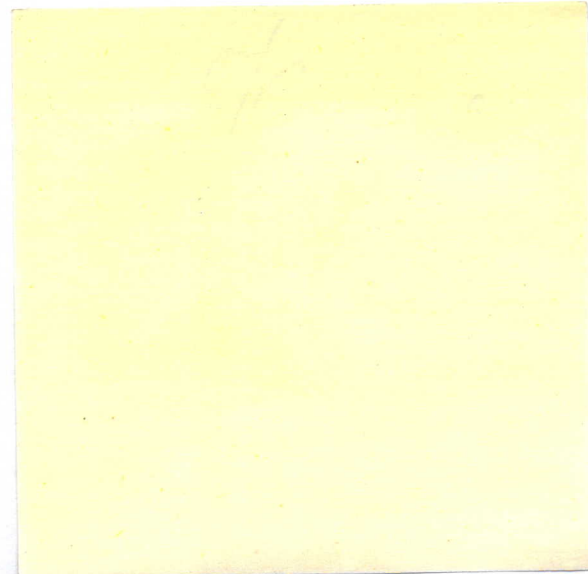

A Review Workshop for the Neeranchal National Watershed Project was held on 2<sup>nd</sup> & 3<sup>rd</sup> November, 2016 at Scope Complex, New Delhi. The detailed agenda of the workshop is at Annexure-I. The Workshop was chaired by Special Secretary (LR). The workshop was attended by the officials of DoLR, the World Bank team, CEOs and officials from the 9 Neeranchal Partner States i.e., Andhra Pradesh, Chhattisgarh, Gujarat, Jharkhand, Maharashtra, Madhya Pradesh, Orissa, Rajasthan and Telangana. List of attendees is at Annexure-II.

2. At the outset, Director (WM) and DDG (WM) welcomed the participants which were followed by customary round of introductions.
3. DDG (WM) in his opening address stated that Neeranchal is going to provide the technological support to WDC-PMKSY and therefore, the Project would be continuously in the limelight. He added that the implementation of the project in a time bound manner will be important for both the DoLR as well as the States. He added that the Annual Action Plans for States had been approved in the last Project Empowered Committee (PEC) meeting and the Department would soon be releasing funds to the States.

In his address Dr. Grant Milne, Neeranchal Task Team Leader, World Bank indicated that Neeranchal would provide the technical and institutional support to build strong foundations for implementation of the WDC-PMKSY. He also indicated that the project would be formally reviewed once every six months. Dr. Milne stressed that timely procurement was key to the successful implementation of the project which was also one of the objectives of the workshop.
